### Information about the product

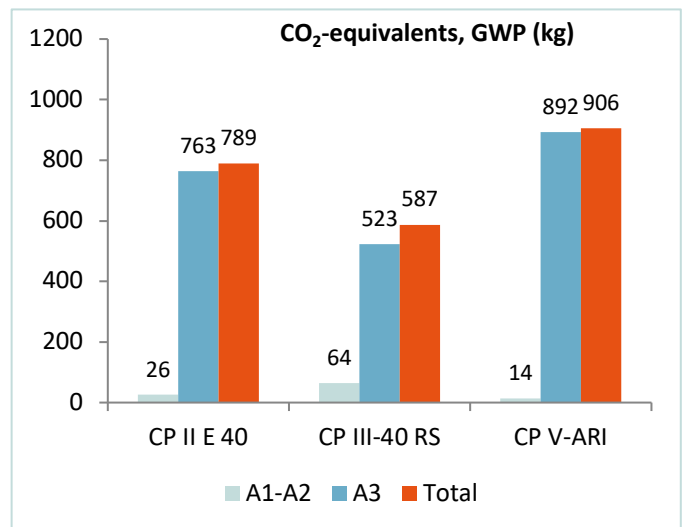
This climate declaration covers 3 cements in bulk form: CP II E 40, CP III-40 RS and CP V-ARI.

### Information about the company

Votorantim Cimentos is the market leader in cement in Brazil and the eighth largest global producer in terms of installed capacity, according to the Global Cement Report 2013 data. The company is part of the Votorantim Group and is present in 14 countries through the South America, North America, Europe, Asia and Africa. It is a large industry that produces cement, concrete, aggregates and complementary products such as mortar and lime.

### Climate declaration

The life cycle assessment is based on the WBCSD-CSI Tool for concrete and cement EPDs, version 1.4, verified as compliant in accordance with the PCRs (PCR 2012:01 Construction products and Construction services v.2.2, PCR 2013:02 Concrete v.1.02, PCR 2010:09 Cement v.2.1., the General Programme Instructions (GPI 2.5) for the International EPD® System. The studied system includes: A1 raw material supply, A2 transport and A3 core processes.
