# Product description

Product description and description of use:

This Environmental Product Declaration (EPD<sup>®</sup>) describes the environmental impacts of 1 m<sup>2</sup> of mineral wool with a thermal resistance of 1.0  $K^*m^{2*}W^{-1}$  and 37 mm of thickness which is a not commercialized product.

The production site of KIMMCO-ISOVER (Saudi Arabia) uses natural and abundant raw materials of natural origin ((i. e. volcanic rock) and recycled materials, using fusion and fiberising techniques to produce stone wool. The products obtained from mineral wools are characterized by its lightness due to its air containing structure that keeps immobile between its intertwined filaments.

On Earth, the best insulator is dry immobile air. At 24°C its thermal conductivity factor, expressed in  $\lambda$ , is 0.025 W/(m.K) (watts per meter Kelvin degree). The thermal conductivity of mineral wool is close to immobile air, and its lambda value is between 0,033 W/(m·K) for the most efficient wools to 0.040 W/(m.K) to the least efficient ones.

With its entangled structure, mineral wool is a porous material that traps the air, making it one of the best insulating materials. The porous and elastic structure of the wool also absorbs noise in the air, knocks and offers acoustic correction inside premises. Mineral wool containing incombustible materials does not fuel fire or propagate flames.

Stone wool insulation is used in buildings as well as industrial facilities. It ensures a high level of comfort, lowers energy costs which minimizes carbon dioxide (CO2) emissions during use phase, prevents heat loss through roofs, walls, floors, boilers and industrial process equipment, reduces noise pollution and protects homes, commercial and industrial facilities from the risk of fire. Stone wool products last for the average building's lifetime (which is often set at 50 years as a default), or as long as the insulated building component is part of the building.



## Product stage, A1-A3

**Description of the stage:** the product stage of the stone wool products is subdivided into 3 modules A1, A2 and A3 respectively "Raw material supply", "transport" and "manufacturing".

The aggregation of the modules A1, A2 and A3 is a possibility considered by the EN 15 804 standard. This rule is applied in this EPD.

Description of the scenarios and other additional technical information:

#### A1, Raw materials supply

This module takes into account the extraction and processing of all raw materials and energy which occur upstream to the studied manufacturing process


Specifically, the raw material supply covers production of binder components and sourcing (quarry) of raw materials for fiber production. Besides these raw materials, recycled materials (agglomerates) are also used as input.

#### A2, Transport to the manufacturer

The raw materials are transported to the manufacturing site. In our case, the modeling include: road (average values) of each raw material.

#### A3, Manufacturing

This module includes the manufacturing of the product and packaging. Specifically, it covers the manufacturing of resin, stone wool (including the processes of fusion and fiberizing showed in the flow diagram), and the packaging.



### Construction process stage, A4-A5

**Description of the stage:** the construction process is divided into 2 modules: A4, transport to the building site and A5, installation in the building.

A4, Transport to the building site: this module includes transport from the production gate to the building site.

Transport is calculated on the basis of a scenario with the parameters described in the following table.

## Use stage (excluding potential savings), B1-B7

Description of the stage: the use stage is divided into the following modules:

- B1: Use
- B2: Maintenance
- B3: Repair
- B4: Replacement
- B5: Refurbishment
- B6: Operational energy use
- B7: Operational water use

#### Description of the scenarios and additional technical information:

Once installation is complete, no actions or technical operations are required during the use stages until the end of life stage. Therefore, stone wool insulation products have no impact (excluding potential energy savings) on this stage.

## End of Life Stage, C1-C4

Description of the stage: this stage includes the next modules:

#### C1, Deconstruction, demolition

The de-construction and/or dismantling of insulation products take part of the demolition of the entire building. In our case, the environmental impact is assumed to be very small and can be neglected

#### C2, Transport to waste processing

The model use for the transportation (see A4, transportation to the building site) is applied.

#### C3, Waste processing for reuse, recovery and/or recycling

The product is considered to be landfilled without reuse, recovery or recycling.

#### C4, Disposal

The stone wool is assumed to be 100% landfilled.

## **LCA results**

LCA model, aggregation of data and environmental impact are calculated from the Gabi software (version 8.7) CML 4.1 impact method has been used, together with Gabi version 2019 and ecoinvent 3.1 databases to obtain the inventory of generic data.

Raw materials and energy consumption, as well as transport distances have been taken directly from the manufacturing plant (Production data according 2018 and transport data according 2018)

All figures refer to a functional unit of 1 m<sup>2</sup> of mineral wool with a thermal resistance of 1.0  $K^*m^{2*}W^{-1}$  for a thickness of 37mm, which is a not commercialized thickness, for obtain the result of commercial thickness please address to the conversion factor in addition information section.

# **LCA** interpretation

The following figure refers to a functional unit 1 m<sup>2</sup> of mineral wool with a thermal resistance of 1.0  $K^*m^{2*}W^{-1}$  for a thickness of 37mm.



[1] This indicator corresponds to the abiotic depletion potential of fossil resources.

[2] This indicator corresponds to the total use of primary energy.

[3] This indicator corresponds to the use of net fresh water.

[4] This indicator corresponds to the sum of hazardous, non-hazardous and radioactive waste disposed.

#### Global Warming Potential (Climate Change) (GWP)

When analyzing the above figure for GWP, it can clearly be seen that the majority of contribution to this environmental impact is from the production modules (A1 - A3). This is primarily because the sources of greenhouse gas emissions are predominant in this part of the life cycle. CO2 is generated upstream from the production of electricity and is also released on site by the combustion of natural gas. We can see that other sections of the life cycle also contribute to the GWP; however the production modules contribute to 89% of the contribution. Combustion of fuel in transport vehicles will generate the second highest percentage of greenhouse gas emissions.

#### Non-renewable resources consumptions

We can see that the consumption of non – renewable resources is once more found to have the highest value in the production modules. This is because a large quantity of natural gas is consumed within the factory, and non – renewable fuels such as natural gas and coal are used to generate the large amount of electricity we use. The contribution to this impact from the other modules is very small and primarily due to the non – renewable resources consumed during transportation.

#### **Energy Consumptions**

As we can see, modules A1 - A3 have the highest contribution to total energy consumption. Energy in the form of electricity and natural gas is consumed in a vast quantity during the manufacture of stone mineral wool so we would expect the production modules to contribute the most to this impact category.

#### Water Consumption

As we don't use water in any of the other modules (A4 - A5, B1 - B7, C1 - C4), we can see that there is no contribution to water consumption. For the production phase, water is used within the manufacturing facility and therefore we see the highest contribution here. However, we recycle a lot of the water on site so the contribution is still relatively low.


#### Waste Production

Waste production does not follow the same trend as the above environmental impacts. The largest contributor is the end of life module. This is because the entire product is sent to landfill once it reaches the end of life state. However, there is a still an impact associated with the production module since we do generate waste on site. The very small impact associated with installation is due to the loss rate of product during implementation.

### Influence of particular thickness

This EPD includes a range of thicknesses, from 30 to 220 mm, using a multiplication factor in order to obtain the environmental performance of every thickness. In order to calculate the multiplication factors, a reference unit has been selected with a value of R=1 m2\*K/W for 37 mm of thickness. All results refer to 37 mm of thickness.

The following table shows the multiplication factor for each individual thickness in the product family. In order to determine the environmental impacts associated with a determinate product thickness, the results indicated in this EPD must be multiplies by the corresponding multiplication factor. To obtain this factor, a conservative principle has been followed, being the real impact of the product slightly lower than the indicated in the table.
