Information about the product

Kalesinterflex® Porcelain Ceramic Slab is a porcelain ceramic slab with has two options; with and without fibreglass backing. It is primarily made of clay, kaolin and feldspar but they also include other raw materials.

Kalesinterflex® Porcelain Ceramic Slab is a chemical resistant porcelain ceramic slab suitable for interior, exterior, facade, residential, countertops/bench tops, splash-backs, cladding, wet areas, light commercial floors and walls.
