Product description

Product description and use:

This Environmental Product Declaration (EPD®) describes the environmental impacts of 1 m² of Tuyango plaster projected into the indoor wall.

Tuyango projectable plaster is made up of hemihydrate calcium sulphate (95%) and chemicals additives which provide the product-specific characteristic of performance. It consumes around 9-10 kg per m2 and 1 cm of thickness of plaster.

Tuyango projectable plaster is designed to simplify the application in an easy way and saving a lot of time, thanks to the use of projectable machine. Suitable for using in different indoor surfaces' applications such as bricks wall, cement ceiling, etc.

During it application it is really important to respect the recommended water/plaster relation in order to do not alter the mechanical performance and the application.

The packaging used is a polypropylene bag that contains 30 kg pf plaster.

Flow diagram of the Life Cycle



Product stage, A1-A3

Description of the stage: the product stage of plaster products is subdivided into 3 modules A1, A2 and A3 respectively "Raw material supply", "transport to manufacturer" and "manufacturing".

A1, raw material supply.

This includes the extraction and processing of all raw materials and energy which occur upstream from the manufacturing process.


A2, transport to the manufacturer.

The raw materials are transported to the manufacturing site. The modelling includes road, boat and/or train transportations of each raw material.

A3, manufacturing.

This module includes the manufacture of products and the manufacture of packaging. The production of packaging material is taken into account at this stage. The processing of any waste arising from this stage is also included.

Manufacturing process flow diagram



Manufacturing in detail:

The initial materials are homogenously mixed to form a gypsum powder that is packed on polypropylene bags.

Construction process stage, A4-A5

Description of the stage: the construction process is divided into 2 modules: A4, transport to the building site and A5, installation in the building

A4, transport to the building site.

This module includes transport from the production gate to the building site. Transport is calculated on the basis of a scenario with the parameters described in the following table.



LCA results interpretation

The following figure refers to a functional unit of 1 m2 of projectable plaster with 10mm thickness, a weight of 9.5 kg $/m^2$ and a density of 650-750 kg/m3.



- [1] This indicator corresponds to the abiotic depletion potential of fossil resources.
- [2] This indicator corresponds to the total use of primary energy.
- [3] This indicator corresponds to the use of net fresh water.
- [4] This indicator corresponds to the sum of hazardous, non-hazardous and radioactive waste disposed.

Global Warming Potential (Climate Change) (GWP)

When analyzing the above figure for GWP, it can clearly be seen that the majority of contribution to this environmental impact is from the production modules (A1 - A3). This is primarily because the sources of greenhouse gas emissions are predominant in this part of the life cycle. CO2 is generated upstream from the production of electricity and is also released on site by the combustion of natural gas. We can see that other sections of the life cycle also contribute to the GWP; however, the production modules contribute to over 80% of the contribution. The installation phase will generate the second highest percentage of greenhouse gas emissions, followed by end-of-life and distribution phase.

Non-renewable resources consumptions

We can see that the consumption of non – renewable resources is once more found to have the highest value in the production modules. This is because a large quantity of natural gas is consumed within the factory, and non – renewable fuels are used to generate the large amount of electricity we use. The contribution to this impact from the other modules is very small and primarily due to the non – renewable resources consumed during transportation.

Energy Consumptions

As we can see, modules A1 - A3 have the highest contribution to total energy consumption. Energy in the form of electricity and natural gas is consumed in a vast quantity during the manufacture of plaster so we would expect the production modules to contribute the most to this impact category.

Water Consumption

As we don't use water in any of the other modules (A4, B1 – B7, C1 – C4), we can see that there is no contribution to water consumption. For the production phase, water refers to upstream (water used in the raw material extraction and manufacture and for energy production) is the highest contribution. The second contributor is the installation phase due to the fact that the plaster powder need water to be applied. The last and small contribution (stage C) comes from the waste treatment.


Waste Production

Waste production does not follow the same trend as the above environmental impacts. The largest contributor is the end of life module. This is because the entire product is assumed here to be sent to landfill once it reaches the end of life state. However, there is a still a small impact associated with the installation module since we do generate a loss rate of product during implementation.
