Information about the product

The actuator product for perfume containers (UN CPC 4299) is a component manufactured entirely from anodised aluminium integrated into perfume containers (100% by weight aluminium), whose function is to facilitate the dispersion mechanism of the perfume contained in such container. This product is manufactured by hook and bulk in a wide range of diameters.
