The climate declaration shows the emissions of greenhouse gases, expressed as CO₂ equivalents. It is based on verified results from a lifecycle assessment (LCA) performed as basis for an EPD[®], in accordance with ISO 14025.

Information about the product

This Climate Declaration describes the emissions of greenhouses gases over the life cycle of RBI 12.5 mm – Moisture resistant plasterboard with gypsum core and additives to reduce the water absorption rate, firmly bonded to strong paper liner. Moisture resistant plasterboard is suitable for dry lining internal surfaces.

The scope is cradle to gate with options including modules A1-3, A4, A5, B1, B2, B3, B4, B5, B6, B7, C1, C2, C3 and C4.
