

C1	The impacts associated with the demolition are assumed to be negligible.
C2	The end-of-life product is sent to disposal with the CER code of chapter 17. The landfill disposal at a distance of 50 km is taken as a scenario. The means of transport is represented by the following dataset Transport, freight lorry, 16-32 EUR 4.
C3	The product after the demolition activities is not recovered. This module therefore contains only the benefits and impacts due to the recycling and energy recovery of product packaging materials.
C4	After demolition, the product is disposed in the landfills, the dataset used is Inert waste for final disposal CH treatment of inert waste, inert waste material landfill. This choice is dictated by the fact that the waste is classified with the CER code of chapter 17.
D	This module contains the potential impacts and benefits associated with the recycling of the product aimed at the production of new glass wool in the event that waste management takes place in an optimal way. The calculated value is excluded from the sum of the total impacts.





The parameter chosen for the initial inclusion of input and output elements is based on the definition of a cut-off level of 1%, in terms of mass, energy and environmental relevance. This means that a process has been neglected if it is responsible for less than 1% of the total mass, primary energy and total impact. However all the processes for which the data are available have been taken into consideration, even if with a contribution of less than 1%.

The method chosen to assess the potential environmental impacts of the product covered by this study is provided by the standard EN 15804 (CEN, 2019).

Modeling of electrical energy (Module A3): The modeling of electricity consumption in Module A3 was carried out using the Italian national residual mix (using as a source of data from the latest AIB report (AIB, 2019)). The breakdown of the energy sources used is given. The emission factor obtained is equal to  $645 \text{ gCO}_2\text{eq/kWh}$ .

For the Climate Change impact category a value of  $8.50E+00~kg~CO_2~eq$  is obtained. This impact is mainly due to the electricity group ( $3.02E+00~kg~CO_2~eq$ ; 35.48%) and to the methane and diesel group ( $1.85E+00~kg~CO_2~eq$ ; 21.71%). The dressing, oils and coatings group also contributes to the impact ( $1.32E+00~kg~CO_2~eq$ ; 15.49%). In particular, the acrylic resin (for dressings and glue) impacts for 12.09%. Another contribution is made by the machining group in the line ( $1.09E+00~kg~CO_2~eq$ ; 12.78%) especially for emissions during processing. The impacts of this category are mainly due to the emission of carbon dioxide (85.33%) and, to a lesser extent, methane (12.51%).

For the impact category Climate Change (fossil) a value of  $8.42E+00~kg~CO_2$  eq is obtained. This impact is mainly due to the electricity group ( $2.97E-01~kg~CO_2$  eq; 35.22%) and to the methane and diesel group ( $1.84E+00~kg~CO_2$  eq; 21.90%). The dressing, oil and coating group also contributes significantly to the impact ( $1.31E-01~kg~CO_2$  eq; 15.57%). In particular, the acrylic resin (for dressings and glue) impacts for 12.18%. Another contribution is made by the machining group in the line ( $1.08E+00~kg~CO_2$  eq; 12.84%) especially for emissions during processing. The impacts of this category are mainly due to the emission of carbon dioxide (86.14%) and, to a lesser extent, methane (12.62%).





For the impact category **Climate Change (biogenic)** a value of 7.72E-02 kg CO<sub>2</sub> eq is obtained. This impact is mainly due to electricity consumption (3.00E-01 kg  $CO_2$  eq). Other contributions are given by the waste treatment group  $(4.48E-02 \text{ kg } CO_2 \text{ eg})$ , by the processing group in the line (2.86E-02 kg CO<sub>2</sub> eg) and by the benefit and recovery group from recycling (2.47E-02 kg CO<sub>2</sub> eg). This is mainly due to wood. The vitrifiable group (1.57E-02 kg  $CO_2$  eq) and the dressing group and oils (9.98E-03 kg CO2 eq) also contribute to the impact. In particular, the acrylic resin impacts for 12.92%. Impacts in this category are mainly due to the emission of carbon dioxide and, to a lesser extent, methane into the air. The packaging group contributes to the reduction of this type of impact with a negative contribution of -3.42E-01 kg  $CO_2$  eg. This is due to the use of wooden pallets as packaging.

For the impact category <u>Climate Change (land use and transformation)</u> a value of 2.16E-04 kg  $CO_2$  eq is obtained. This impact is mainly due to the oil and coating group (9.32E-04 kg  $CO_2$  eq). In particular, the acrylic resin impacts for 42.52%. The packaging group also contributes significantly to the impact (4.54E-04 kg  $CO_2$  eq; 21.02%). In particular, the pallet impacts for 7.93%. Another significant contribution is made by the use of electricity (1.97E-04 kg  $CO_2$  eq; 9.13%). The impacts for this category are mainly due to the emission of carbon dioxide in the air (99.69%).

For the impact category **Ozone depletion** a value of 1.76E-06 kg CFC<sub>II</sub> eq is obtained. This impact is mainly due to the use of methane and diesel (1.07E-06 kg CFC<sub>II</sub> eq; 61.00%) and electricity (3.68E-07 kg CFC<sub>II</sub> eq; 20.92%). The acrylic resin impacts 7.77%. The impacts of this category are mainly due to the air emission of Halon 1211 (75.43%).

For the <u>Acidification</u> impact category a value of 7.16E-02 mol H $^+$  eq eq is obtained. This impact is mainly due to the use of electricity (3.61E-02 mol H $^+$  eq; 50.35%) and to the dressing, oil and coating group (1.80E-02 mol H $^+$  eq; 25.17%). In particular, the acrylic resin impacted for 24.98%. The impacts of this category are mainly due to the emission of sulphur dioxide (47.20%), ammonia (32.68%) and nitrogen oxides (19.82%) to air.

For the impact category **Eutrophication (aquatic, freshwater)** a value 3.60E-03 kg P eq. is obtained. This impact is mainly due to the use of electricity (1.61E-03 kg P eq; 44.74%). Other contributions are given by the waste and impact group of the plant (1.00E-03 kg P eq; 27.79%) and by the coating and oil group (kg P eq; 19.31%). In particular, the acrylic resin impacts 19.12%. The impacts of this category are mainly due to the release of phosphates into water (99.97%).

For the impact category **Eutrophication (aquatic, marine)** a value 8.99E-03 kg N eq is obtained. This impact is mainly due to the use of electricity (3.12E-03 kg N eq; 34.69%). Other contributions are given by the machining group in the line (2.05E-03 kg N eq; 22.75%) and by the dressing group, oils and coatings (1.45E-03kg N eq; 16.07%). In particular, the acrylic resin impacts 15.86%. The impacts of this category are mainly due to the emission of nitrogen oxides (83.19%) and ammonia (7.95%) in air and, to a lesser extent, to the release of nitrates into water (7.41%).

For the impact category **Eutrophication (terrestrial)** a value of 1.86E-01 mol N eq is obtained. This impact is mainly due to the use of electricity (1.15E-01 mol N eq; 61.70%). Another significant one is given by the machining group in the line (3.01E-02 mol N eq; 16.15%). The acrylic resin impacts for 9.03%. The impacts of this category are mainly due to the emission of ammonia (56.09%) and nitrogen oxides (43.91%) to air.

For the impact category **Photochemical ozone formation** a value of 2.79E-02 NMVOC eq is obtained. This impact is mainly due to the use of electricity (7.11E-03 kg NMVOC eq; 25.47%). Other contributions are given by the machining group in the line (5.62E-03 kg NMVOC eq; 20.14%), and by the dressing group, oils and coatings (5.33E-03 kg NMVOC eq; 19.08%). In particular, the acrylic resin impacts for 17.80%. The use of methane and diesel also contributes significantly to the impact (4.37E-03 kg NMVOC eq; 15.65%). The impacts of this category are mainly due to the emission of nitrogen oxides (68.70%), NMVOC of unspecified origin (16.05%) and sulphur dioxide (7.49%) to air.





For the impact category Abiotic Depletion Potential (mineral and metals) a value of 1.08E-05 kg Sb eq. eq is obtained. This impact is mainly due to the dressing, oil and coating group (7.10E-06 kg Sb eq; 65.95%). In particular, the acrylic resin impacts 64.53%. Another significant contribution is made by the waste and impact group of the plant (8.06E-07 kg Sb eq; 7.49%). The impacts of this category are mainly due to the use of raw materials as metals, in particular cadmium (14.43%).

For the impact category Abiotic Depletion Potential (fossil) a value of 6.07E+01 MJ is obtained. This impact is mainly due to the use of methane and diesel (2.75E+01 MJ; 45.24%) and electricity (1.75E+01 MJ; 28.90%). Another contribution is made by the group of resins and oils (2.33E+01 MJ; 12.67%). In particular, the acrylic resin is coated for 12.18%. The impacts of this category are mainly due to the use of raw materials such as natural gas (62.30%), coal (15.83%), and oil (13.23%).

For the impact category <u>Water use</u> a value of  $3.75E+00 \text{ m}^3$  is obtained. This impact is mainly due to the resins and oils  $(1.38E+00 \text{ m}^3; 36.72\%)$ . In particular, the acrylic resin impacts for 36.46%. Other contributions are given by the machining group in the line  $(1.28E+00 \text{ m}^3; 34.19\%)$  mainly for water and oxygen consumption and by the electric power group  $(5.47E-01 \text{ m}^3; 14.61\%)$ .

## Type and data source

Choosing the data to be used for the LCA study, primary data collected from Eurofibre were endorsed through a measurement campaign carried out between January 2020 and May 2020 in the Marcon (Ve) plant. The primary data cover the period January 2019 - December 2019 and relate to:

- the transport of incoming materials for the production, as well as the auxiliary materials as e.g. the oxygen (distance covered, type of fuel, Euroclass of the vehicles, payload, percentage of vehicle load);
- waste produced (quantity and type) and raw materials used (quantity and type);
- the production process of insulation at Eurofibre (mass balance and energy consumption);
- internal transport and operating machines used at Eurofibre;
- the transport of the waste produced to the destination plant (distance covered, type of fuel, Euro class of the vehicles, vehicle load, percentage of vehicle load);
- diesel and methane consumption for heating;
- lighting and compressed air consumption.

In the event that primary data or models are not available for the calculation of such data, secondary data obtained by consulting internationally recognized databases have been used, favoring the use of the most up-to-date ones where possible. The secondary data in particular concern:

- the combustion processes of the vehicles: emissions, maintenance, use of the road network, fuel consumption (Ecoinvent data sets 3.5 version);
- operating machines: emissions (Ecoinvent 3.5 data sets);
- electricity: energy mix, distribution network, sulfur hexafloride emissions, losses (Ecoinvent data set 3.5);
- the production of the materials used (Ecoinvent 3.5 data sets).

The proxy data are less than 10% as required by the program rules.
